In keeping with the Humanities Council mission of service, access to e-WV is free to the user and available to anyone.

West Virginia Folklife Program and Direct Humanities Projects - The West Virginia Folklore program works to document, sustain, present and support West Virginia's vibrant cultural heritage and living traditions.
